SHORT-TERM DISABILITY (STD) ELIMINATION PERIOD FOR MEMBERS OF AIR CANADA

We are pleased to bring you good news and announce that effective **November 28, 2021** (this pertains to a disability absence on and after November 28, 2021) the Short-Term Disability (STDI) Elimination Period (waiting period) will be reduced to 7 consecutive days from the current 14 consecutive days. The Employer will complete and forward the Plan Sponsor Statement to our Plan Administrator on the 7th day of your disability absence and they will also send the STDI Claim Application forms to you via email.

SHORT-TERM DISABILITY (STD) MAXIMUM BENEFIT AMOUNT

In addition to the improved benefits outlined above, effective **January 1, 2022**, the STD Phase I benefit maximum will increase from the current 55% of weekly gross earnings to a maximum benefit of \$600.... to 55% of weekly gross earnings to a maximum benefit of \$650 (non-taxable to disabled Member).

There are no increased costs to our Membership as a result of these improved benefits; however, your Trustees through the Plan Administrator will monitor closely any emerging financial experience as a result of these improvements.
