HEALTH SPENDING ACCOUNT (HSA)

The Board of Trustees for the Health and Welfare Trust Fund reminds you that the Health Spending Account Program will end on July 31, 2024. Health Spending Account claims must be received at the Plan Administrator's office no later than **5:00** pm EST July 31, 2024.

Due to the large volume of claims usually submitted at the end of the program year, we encourage you to submit your complete claim information by June 1, 2024. Claims received after that date are usually delayed **90 days** for processing.

GIDIP CLAIMS EXPERIENCE SURVEY

Effective June 1, 2024, when your GIDIP STD claim closes, you will receive a GIDIP Claims Experience Survey from the Plan Administrator. We encourage you to respond to the survey to help the GIDIP plan better meet your expectations.

SUBMITTING MEDICAL INFORMATION

GIDIP is a medically supported income replacement benefit, requiring medical information to support your claim.

Please submit your medical information to the Plan Administrator, Canadian Benefits Consulting Group. For confidentiality purposes, your medical information should not be forwarded to the Trustees or any other Union members. This will also help ensure that your information is received as quickly as possible.

The receipt of medical information in support of your claim, is not approval of your claim. To expedite your claim, we recommend that you ensure that your treatment providers confirm clear and concise information on their Attending Physician Statement (APS).
